**From West (Madison):** Take I-94 E. Keep left to continue on I-794 E. Immediately take exit 1H for Saint Paul Avenue/James Lovell Street. Follow signs for W St Paul Ave. Turn left onto W St Paul Ave. The Amtrak-Intermodal Station will be on the right.

**From North (Appleton):** Take I-41 S. Take exit 38a-38B for I-94 E/I-94 W. Keep left to continue on I-94 E. See **From West** directions for remainder of directions.

**From North (Green Bay):** Take I-43 S. Take exit 72B for I-794 E. Keep right to continue on exit 1D. Follow signs for Plankinton Ave. Turn left onto W Clybourn St. Turn left onto N 5<sup>th</sup> St. The Amtrak-Intermodal Station will be straight ahead.

**Parking:** There is a public lot adjacent to the Amtrak bus loading area and one across the street from the passenger drop-off. Metered street parking is also available.
